3. President's Report – Tighe Patching

Challenging 12 month period for the club, with heavy restrictions on flying and the ability of members to meet.

Club has continued to be successfully run and improved, with some significant decisions made through the year. CQP was sold and planning for a new glider (consistent with the Club's Fleet Strategy), and a major instrumentation upgrade was purchased, with Richard Traill leading the project.

Consistent flying membership with an increase of six flying members on last year. The aim is to increase flying members up to over 100, and to increase flying hours per member

Threats which have emerged, continued or been dealt with through 2020-21 included:

- Airspace review proposed by Airservices Australia: Special thanks provided to Matt Swinn for his work in providing a feedback report on behalf of the club. This threat has dissipated for now.
- Western Transmission Line: High voltage power corridor which threatened the airspace surrounding Bacchus Marsh airfield. Of the two possible corridors being considered, the less-impactful Northern corridor is now the preferred option.
- Legal action between BMAM and TVSA flying school: Ongoing, and expected to not be resolved for ~12 months.

There are many post-Covid opportunities for the Club to explore. A strong interest in gliding has been apparent, with many potential members reaching out to the Club.

Tighe highlighted the importance of a volunteer culture to enable the continued operation of the club.

On stepping down from the role of President, Tighe thanked the club for the honour of continuing a family tradition as Club President, and provided specific thanks to the contributions of the committee members and club members for their support.

4. Treasurer's Report – Anthony (T) Carling

Treasurer's report and brief provided by Tony Carling

Major financial events:

- COVID
- BCK Airframe overhaul (within funding provision)
- COP Sale
- Re-assessment of glider maintenance provision
- ~\$15k cash burn rate in a COVID year

Accounting changes:

- Change to methodology for the year in which membership fees are counted, in order to simplify handling of EOFY accounts.

Positive factors:

- No bad debts
- Tug overhauls completed within cash reserve
- Strong ab-initio flying
- COVID grants from State Government
- CQP sale
- Purchase of S100 Varios
- Positive cash flow

Challenges

- COVID
- AEF revenue
- Member flying hours (camps especially)
- Asset replacement saving
- Use of David Wilson memorial fund scholarship unclaimed

There were periods of no flying during lockdown (22 weeks impacted), with strong recoveries in the short windows between lockdowns. Large period of no AEFs, with a gradual recovery, but below previous years.

Positive cash flow of \$26,391 for previous year – less immediate operating expenses. Out of this needs to come

- Depreciation / asset replacement
- Maintenance
- Insurance provision
- Bad debts

Estimate of \$26k shortfall in order to cover these provisions.

Floor opened for questions:

- Nil, comment provided by Tighe that the club is cash positive but must plan for the future.

Tighe Patching provided a specific thanks to Tony Carling on behalf of the club, for his work as Treasurer over the past six years.

Tony thanked Michael Aldridge in his work processing flight sheets and in setting up many automations and workflow improvements. TC plans to nominate as financial reviewer for next year's accounts.

Tony provided the club with a brief on the new AEF form process he has implemented.

5. CFI Report - Mark Hunt / Paul Spooner

Mark thanked Paul for his work in the role of CFI during the past five years. COVID restrictions led to some challenges, particularly with regard to loss of currency of the entire instructor roster during lockdowns. Weekday annual checks used in order to rapidly resume normal operations. Ground school sessions conducted online to maintain some engagement with students during lockdown.

Mark pointed out the GFA 'Currency Barometer' standards – encourages members to seek check-flights and be mindful of the conditions when their currency is lower than typical.

- Three first solos conducted in past 12 months (Andrew Callegari, Nick Callegari (return to gliding), Alberto Casal-Barreiro)
- 1-week course planned for post-COVID period
- Regular Condor flying
- Some good cross-countries at Raywood Christmas Camp

Threats and learnings from past year:

- Airspace breaches
- Wheels-up landings
- Currency

Pending COVID:

- Melbourne Cup Weekend Raywood
- Christmas Camp Wangaratta
- Horsham Coaching Week
- Easter Camp (Benalla)

Currently aiming at a full instructor roster, by both training some new instructors and bringing back some old hands.

Will be encouraging members to participate in both club camps and non-club camps.

10. Other business and Q&A

TP opened the floor for questions:

Roger Druce: "Do we have a functional safety representative in the club?"

- TP: We do have a member in this role, but the incoming committee will have a discussion with this member on their intentions moving into the coming year.

Tony Carling: "Are there any other positions to put a call out for, outside of the previously mentioned committee roles?"

- TP: Maintenance remains an ever-present demand, and any members with an interest should contact Richard Traill. Tegan Lodge has offered to take on the Lead Duty Pilot role. The president and treasurer roles remain the most important roles which currently require fulfilment.

Roger Druce provided comments on airworthiness:

- NDG is being repaired to fix damage to the undercarriage. A significant amount of reassembly will need to be performed at Bacchus Marsh, as the glider was stripped prior to maintenance. This presents an excellent opportunity for learning about sailplane internals and the assembly of the aircraft.
- COVID is pushing maintenance work in the later part of the year volunteer support is appreciated and required to facilitate this effort.
